OIC Kyle Amidon was present to review his report. He introduced SRO Nicole Cowdrick to the board. He informed the board that the radio continues to be on back order but the new car is working great and officers should be able to start writing more tickets. He asked for the board's approval to purchase 3 fire extinguishers. 2 for the cars and 1 for the office. The board approved this request unanimously.

OIC Amidon also reminded the board of the contract with Canisteo and that a decision should be made. He continued by mentioning that only 1 officer that works in North Hornell is actually working in Canisteo respectively. After a short discussion, the board agreed it would contact the Village of Canisteo to let them know that North Hornell appreciates their assistance in getting the Police Department up and running and now they are going to move forward with funding the police department on their own. Mayor Ingalls will prepare a letter informing The Village of Canisteo of this decision.

A motion to discontinue the contract with the Village of Canisteo in the amount of \$5,000.00 annually for funding a portion of the North Hornell Police Department was made by Trustee Peter DiRaimondo, second by Mayor J. Joseph Ingalls and carried.

## MAINTENANCE REPORT

Trustee Flint asked Superintendent why his water pressure seems to be low. Superintendent asked Kristene Libordi if she had noticed a change in her pressure. She said she did notice a little bit of a change. Superintendent Scavo asked for them to keep him posted.

Superintendent Scavo told the board the retaining wall is complete with the exception of 3 caps and then seeding to come in. After these items come in, the project will be finished. He told the board that the project would have taken much longer and would have been more laborious for him, Charlie and Skyler if they didn't have the assistance from the Town of Hornellsville. He asked if a letter of thanks could be sent to the Town of Hornellsville for all of their assistance. Mayor Ingalls mentioned he may even attend the Town meeting to thank them in person but would definitely send a letter of thanks.

Superintendent Scavo inquired about the \$7,500.00 that was agreed to be moved from the Streets account to the CHIPS account to prepare for future road repair. Mayor Ingalls informed him that the money was put in the Fund Balance.

Superintendent Scavo also told the board that the part time employee Skyler Button is working out very well. Currently he is getting 15-20 hours a week. When the water project begins, he may need Skyler for more hours and would like consideration for possibly 25 hours. This will be further discussed at the time gets closer.

The auction on the dump truck currently is at \$18,100.00 with bidding to close on June 13, 2023. At this time, Superintendent Scavo does not believe there is any charge for the auction service he believes the charges are all put to the buyer. He will inform the board of the closing bids as soon as he knows.

# BUDGETARY AMENDMENT TO 21-2023 RESOLUTION PURCHASE OF FIRE DEPARTMENT VEHICLE

The following Resolution was offered by Mayor J. Joseph Ingalls, seconded by Trustee Leroy Forshee and carried,

**RESOLVED,** that the Village of North Hornell Board of Trustees at their Monthly Board Meeting on June 12, 2023 approved the purchase of a 2022 Dodge 2500 Ram Pick-up Truck, for the fire department, in the amount of \$53,811.50 from Maple City Dodge.

\$33,444.50 will come from A230 Fire Department Reserves, anticipated \$6,000.00 from sale of current apparatus put out for bid, \$14,367.00 from Fund Balance. \*\*Amendment to 21-2023 Resolution due to new information regarding the invoice received from Maple City Dodge for the truck being purchased.

The Fire Company will fund the outfitting of the back end of the truck with a truck cap, decked drawer system, tools, decaling, etc. at an anticipated expense of \$17,566.62.
