## FLOORING IN NEW FIRE HALL

Contractor Joe Rose explained the problems with using the spec'd flooring. Moisture tests will not permit the use of the spec'd epoxy and he has recommendations from manufacturers not to use it. If used it will peel . Sherwin Williams has a secondary coating that will be acceptable if  $1/8^{th}$  of an inch is applied. The board approved the use of the Sherwin Williams product to be used at an  $1/8^{th}$  of an inch application.

#### **CEILING FAN**

Architect Rex Simpson is requesting that a fan be installed in the boiler room. Contractor Mazza would put in a motorized damper in the boiler room at a cost of \$3400. Contractor Rose is estimating the installation cost to be no more than \$250 and if more, he will pay.

# EXHAUST FAN IN TRUCK BAY

Architect Simpson is requesting two fans be put in the truck bay instead of just one. The cost would be \$3700 and they are a 3<sup>rd</sup> of a horse power single phase fans.

Motion made by Trustee DiRaimondo to approve replacing one fan with two in the truck bay at a cost of \$3700 to be paid to Mazza. Motion seconded by Trustee Thomas and carried.
