#### MR BRIAN FRIEDLAND - WATER PROBLEMS

Mr. Friedland had low water pressure at his residence and based on the Village's recommendation that the cause was most likely from his old galvanized water pipes, he had them replaced. This did not solve the problem The main water line was found to have a leak by the City of Hornell water department, and once it was repaired he had good pressure. Mr. Friedland would like some compensation for the damage done to his drive and other expenses incurred.

The board would like to get more information and the Mayor will talk to Mr. Friedland's plumber and the City water department before making any determination on the claim.

# MR. & MRS HELMER – 911 CALLS

Mr. & Mrs. Helmer attended the meeting as a follow up to the February meeting. They expressed their dissatisfaction with 911's response to an accident involving Mrs. Helmer. They are still questioning 911's response time to the accident and are now asking if the board is going to do something about it for future 911 calls. Fire Chief Robbins stated that the same situation happened on a call the day after the Helmer accident. He agrees with the Helmers regarding the slow response. Mayor Falci asked that Chief Robbins make recommendations for the board and they will be forwarded to the 911 administrator.

Trustee Libordi stated that we should invite the 911 administrator Mr. Hopkins to a meeting. Mayor Falci would like to listen to the 911 call and make suggestions to the county legislature.

## SENECA ST BRIDGE

There were questions regarding signage for businesses in the Real Incorporated building. Stacie Schieder owner asked how traffic will be directed. Mayor Falci stated that signage would be in place to direct traffic down Mary St. to Marick Park and then to Cameron St. The signs would be placed by Ramsey Construction. Mayor Falci will ask Mr. Tom Richardson from Ramsey Construction to be present at the May 13<sup>th</sup> meeting.
