# GENERAL CODE ANALYSIS

There will be a work session on September 27<sup>th</sup> following the public hearing held at 6PM. October 12 there will be a workshop at 6PM before the regular board meeting. Fencing and setback are two items that the Zoning Board Chair would like to see addressed.

#### MARY SMITH GRANT WRITER

Mrs. Smith was not available due to illness in family. She has finished the FEMA grant and waiting to hear results. She is meeting with the USDA on a grant for a tanker. She is also looking into an IUP (Intended Use Plan) regarding sewer and water in conjunction with the Seneca Rd. plan.

#### SENECA RD HOUSE

Several complaints received on a Seneca Rd. home. The owner is working to rectify the problems. The Mayor and Code Enforcement will keep up with the progress.

## **UNIT METERS**

Mayor Falci has talked to Mayor Hogan regarding the description of unit water meters. The City states that any house with a business and a residence in the same location will be billed twice. Mr. Hoffman whose home is in question still maintains that he is assessed as a single residence and the assessor doesn't see that he should be reclassified. Mr. Hoffman believes that since the City is under contract with the Village then the city should abide by the legal description that the Village puts on his building as a single residence. There were also several complaints regarding the new surcharge that has been placed on Village water bills. Mayor Falci noted that the Village attorney is looking into the legality of the surcharge. There were complaints regarding dirty water in the Village over the past two weeks. The Mayor has been in contact with the City and it is believed that the problem may be caused by the use of fire hydrants on construction sites outside the City.
