#### PLANNING BOARD - SHEDS

PB Chairman Joe Ingalls read a letter from the PB to the Mayor and Trustees stating that PB is in agreement with CEO Rusby that Local Law#1 of 2008 clearly states that garden sheds not exceeding 144sq. ft. are not required to obtain a building permit. Also the PB will take no further action regarding sheds.

Mayor Falci made a motion to accept the Planning Boards version on the interpretation of the law. There was no second. The issue was tabled.

Resident Jim Bebout is not in agreement with the ruling. He believes that his neighbors shed should be moved at least 3' off the property line.
