Mayor Falci opened the meeting with the Pledge.

The Mayor introduced Superintendent Scavo who gave an update on the water problem (very low water pressure to a few residents on Seneca Rd from Linwood to Elmwood Ave). Lu Engineers quoted \$4,000 to design & submit the plans for the water project addressing problems from Linwood Ave. to Cameron St. on Seneca Rd. The cost would increase to \$7,000 if Lu Engineer would prepare the bid documents. The DPW would not be equipped to do the work unless additional help would be provided. Directional boring would be needed for under driveways. For the first part of the project, 5 taps needed from the Hooker home to the Fahl home. This project would not interfere with the new sidewalks and curbs if done after that project is completed. Superintendent Scavo stated the work would be done in the front yards of the residents and not near the sidewalks. The Superintendent will have costs for directional boring at next month's meeting.
