Superintendent Richard Scavo gave the Maintenance Report.

NEW BUSINESS

GENERAL CODE PUBLISHING

CEO Rusby stated that any local laws that have not been included in code book need to be addressed. The board started in 2005 to revamp the code book but did not complete. The board asked the clerk to have CEO Rusby to look at the 2005 book recommendations and to reach out to General Code Pub on costs.

AVONDALE PROPERTY DEVELOPMENT

Mayor wants an official recommendation from the Planning Board on their findings regarding development of the Avondale property. He will contact the Village attorney regarding the sale of the property and will discuss at the next month board meeting. He will contact PB Chair Maureen Broughton.

OLD BUSINESS

TAP UPDATE

Trustee Ingalls and DiRaimondo gave an update on Tap:

They have received 7 proposals from various consultants.

They are in the selection phase and will set up a presentation with the full board after 3 consultants have been selected.

Met with Todd Stauring at DOT to help with the selection process.

Looking at a 2019 construction season start date.

Would like to have consultant who has worked on ADH construction over the past 2 year

In RFP percentages were given on how consultants would be scored. There are 5 different categories used.

OTHER

CHAMBERS ST - SPEED BUMPS

Trustee McCollum reported that she has been asked by Chambers St and Seneca Rd Residents to investigate the possibility of speed bumps on Chambers St. They are still having problems with speeding vehicles traveling on this street. Trustee Ingalls suggested a dialogue with someone from the DOT.

Trustee McCollumn would like to start conversation on Seneca Rd traffic that will be generated by the new hospital. Trustee Ingalls noted that part of this will be addressed in the design phase of the TAP depending on bicycle lanes. He also asked if we could get a copy of the updated traffic counts from the Town. It was noted again that there needs to be a Police presence during the day to handle traffic issues. Mayor will speak to OIC Richardson

FIRE COMPANY - GRIEVANCES

Fire Company President Chris Patterson gave the following list of grievances with the Village board:

Personal attacks on the company by certain people on this board

There have been special meetings to deal with personnel (firefighters) taking place

Multiple Village board members going to area businesses and departments asking questions about the Fire Company (No one has asked these questions of the Fire Company)

Policies are not supposed to be just for the fire company but minutes (7-10-17) read the "Fire Department Accident Policy"

Volunteer fire members will turn their gear in because of this

Meetings have taken place with no minutes regarding fire personnel from 9-25-17 to 10-2-2017 These could be illegal meetings

Would like a clear line of communication between the fire members and the Village board

Elderwood has told them that they have been asked questions that should be directed to the fire company

Trustee Libordi stated that he had been to Elderwood asking questions and had foiled information from Steuben County 911. This goes back to last month when there was a change made with the Hornell Fire Department taken off the call boxes. The board unanimously wanted the Hornell Fire Department placed back on the call box immediately.

President Patterson stated that if Hornell was called and their truck was in an accident, the Village would be liable for the damaged truck. The Board was not aware of that.

Discussion continued regarding the call to Elderwood last month and what happened at Elderwood between the North Hornell Fire Department and Hornell Fire. The Village Fire department questioned why Trustee Libordi didn't talk to them about the incident.

Trustee Ingalls stated that call boxes were changed without any discussion with the board.

Trustee McCollumn who attended the Fire Company meeting held to give information on the incident gave the board a description of what she was told.

Fire Chief Robbins stated that the bottom line is not the box alarm issue, but between the firefighters and every Village Board member.

Mayor Falci stated that the board did not ask for an opinion from the fire department when they had the two meetings because they were gathering information to see if they should pursue a possible problem of insubordination. Then they would make the judgment to sit down with the Fire Company. He reaffirmed that the board and fire department need to work together.

Mr. Patterson stated that they can talk to the board with the exception of Trustee Libordi. He asked if Trustee Libordi had faith in their job.

Trustee Libordi stated that Chief Robbins was very disrespectful to the board and Mayor at last month's meeting and refused to answer certain questions. He asked Chief Robbins if he emailed (immediately) the order he receive from the board to put Hornell back on the call box. Chief Robbins stated yes. However he cannot show proof that it was done. He does not know what happened to it. Trustee Libordi stated that there is no proof that the Chief did what he was told to do but he expects the board to believe him.

Trustee Libordi was asked again if he trusts the Fire Department and he stated yes.

More discussion between Fire Department and Trustee Libordi and discussion regarding the problems between North Hornell and Hornell fire departments.

President Patterson stated that there will be changes made to separate by-laws that are Fire Company or Fire Department.

Trustee McCollumn stated that the incident at Elderwood facilitated the conversation the board had at the special meetings. The meetings were about why Hornell wasn't called to Elderwood. The board didn't know the call box hadn't been changed. Since the Mayor gave a directive to have it changed the next day, the board thought it had happened. The board had asked for a follow up letter stating that it had been taken care of. They did not receive it. Mayor Falci concluded that communication is important.

RESOLUTION 25-2017

Mayor Falci explained the resolution regarding the land exchange between Ed and Michele Flaitz and the Village. Board to read and it will be on next month's meeting.
