POLICE REPORT

OIC Scott Richardson was not in attendance. Mayor Falci went over the Police Report.

There were complaints from Chambers St. residents regarding vehicles pulling out of and driving the wrong way on Chambers St. The Mayor stated that most of these were heavy equipment trucks that have a difficult time pulling out to Seneca Rd. with traffic coming from the bridge. Mayor spoke with OIC Richardson regarding his new position at the Alfred State Police Academy. OIC stated that this would not have an effect on his duties in the Village. Trustee Ingalls stated that there should be more discussion on commercial traffic on Seneca. The board has talked about what traffic we should control and why. It should be based more on weight restrictions and not just commercial vehicles. Seneca Rd. resident Mr. Poplawski would like all commercial traffic, irregardless of weight, restricted from using the road. He would like the volume of traffic controlled. Trustee Ingalls would like to change the Village law on Commercial traffic. We can't control the volume but we can control the weight restrictions. Trustee Libordi attended a recent Town Board meeting and inquired about putting "no commercial traffic signs" on Town property to assist in stopping the large commercial vehicles from going thru the Village. Mayor Falci noted that the purpose of the law was to save the streets from damage by semi trucks, flat beds and at the time railroad cars on trailers. It was suggested that there should be a weight and height restrictions for commercial traffic. The board agreed that the intent of the law was to keep the larger vehicles off the road. Mayor stated that at next month's meeting this will be discussed with Officer Richardson.

FIRE DEPARTMENT REPORT

Fire Chief Robinson gave his report for the month.

He stated that the budgeted amount for pump tests and schedule A's was more than he had budgeted. He wanted the board to be aware of this in the event that his budget falls short. They will be \$1317 short for pump tests and Schedule A's and \$668 short in the life safety inspections. This year's budgeted numbers were acquired from previous year's numbers.

Fire Company is going to replace some equipment that they didn't receive from the DEC grant

Annual inspection and service for HURST tools is scheduled

Meeting with City CEO Jeff Johnson on new medical building

Fire prevention with the North Hornell school children was on Oct 11th

Booster drive - \$8,648, Boot drive - \$5,000 & Golf tournament - \$3,233

CODE ENFORCEMENT REPORT

CEO William Rusby was not in attendance. The board went over his report and had a brief discussion on the building permit fees - when do you get one and what projects will dictate a cost for the permit. Possibly the fees need to be looked at again or clarified – confusion as to when you have to get a permit.

MAINTENANCE REPORT

Superintendent Richard Scavo gave his report.

Trustee Libordi asked if grass clippings in the road interfere with the sewer. Superintendent stated that it interferes with the storm drains - builds up on the catch basins. This is a Vehicle and Traffic issue and should be addressed with the Police Dept

A discussion was had on possible water line leaks in the Village and contracting with the Leak Detection Company.

A motion was made by Trustee Libordi to contract with the Leak Detection Company at a cost of under \$4,000 to find possible trouble spots in water lines, seconded by Trustee DiRaimondo and carried.

Superintendent Scavo noted that he had not budgeted for this expenditure. The board determined that it would be taken from A8320.4 Common Water. If that account becomes depleted, then monies will be transferred from the Contingent account.

Trustee Ingalls asked for a map showing water lines off Seneca Rd of the two areas that have been discussed from Cameron St to Jones St. He would like to discuss this at next month's meeting.

Superintendent Scavo noted that Trident Insurance will cover the damage done to the mother board at the Pump Station less the \$1,000 deductable. Replacement cost was \$4,300.

The September flow reports for the sewer were given and show that 11% is from Village and 89% coming out of the Town. When both Village sewer pumps are operating, the city asks that we turn off one of the pumps because they can't handle the excess sewage coming into the City.

Mayor Falci and Trustee Ingalls will be meeting with Mayor Buckley to discuss these sewer issues.

The Sewer truck should be back from repairs soon and ready for cleaning out the catch basins.

NEW BUSINESS

ATTORNEY CONTRACT - CIVIL SERVICE

The Clerk was directed to contact Attorney Eric Shults to have a contract written up between the Village and Attorney Shults. The contract will then be sent to the County Personnel Department for Civil Service.
