PLANNING BOARD - LOCAL LAW CHANGE

The Planning board recommended the following change to Chapter §140-17 Open Space Requirements

Chapter §140-17 Open Space Requirements of the Village of North Hornell Zoning law is to be amended as follows:

- A. A minimum of six (6) feet of open space free from structures (example: carports, awnings or patios) shall be maintained from property lines.
- B. Accessory Structures with a gross floor area of 144 sq. ft. or less, with no foundation, must have a side and back setback of at least three (3) feet for Residential zones.

 A no fee building permit shall be required for the construction or installation of such structures.
