Met with another salesman about tankers and options. Also working on 2% loan, Governor passed law that made the amounts go from \$225,000 to \$375,000 due to rising costs of apparatus

FIRE CONTRACT - TOWN

Mayor Falci noted that the Village does not have the approved Fire Contract from the Town. Trustee Libordi noted that South Hornell signed a two year contract with the Town which gives them the same amount that the Village would be receiving in our fifth year. He suggested that the board may want to consider a two year contract similar to South Hornell. Trustee Thomas stated that we have already submitted a contract to the Town. Mayor Falci stated that we will wait to receive the signed contract from the Town before accepting it.

WARRANT TO COLLECT 2013 -2014 UNPAID VILLAGE TAXES

WALMART pilot

Trustee Libordi asked the Mayor to speak to the newspaper article regarding the PILOT and Wal-Mart. The Mayor stated that the PILOT is in effect for two more years and then the twenty years is complete. If the Empire Zone has run out they cannot use it as a tax write off. After that the property goes on the City of Hornell tax roll, the Village will get 50% of that and share with the Town - 15% to the Town and 35% to the Village. It will be a substantial loss of revenue to the Village. Mayor Falci stated that we were able to improve Village structures because of the PILOT income. In February we should know more regarding the Lowe's PILOT and how to proceed with the next budget.
