He asked the Clerk to check if it was noted in previous minutes. He does feel that it is a health issue if the exhaust is not taken out of the building, especially with the Cancer insurance issues coming up. Trustee Ingalls asked about automated screenings that some landlines with carriers such as Verizon have on resident's phones. This would make a residents phone ring only once. Deputy Clerk Scott stated that if this were to happen too often, than the system would delete that number. The form that is to be mailed out should help to eliminate the problem. She will contact Code Red and discuss the possible problem.
