### RURAL AVE EXTENSION

Mr. & Mrs. Orville Ridgeway purchased land at the end of Rural Ave. and are requesting to hook up to the sewer and water system. DPW Supervisor Zdanowski explained that the Ridgeway's must raise their land to a specific elevation and then put in the sewer laterals at their expense to the Village main. They will have to cut into the existing Rural Ave. pavement and they must return it to its existing condition. The board will look into the Rural Ave. deeds. It is unclear if the Village holds title to the section in front of the Ridgeway property. If it is owned by Patton's Mr. Ridgeway would have to purchase it from them. The DPW would run the water service to the edge of Mr. Ridgeway's property.

Mr. Ridgeway asked permission from the board to cut a tree on Village land that borders his property. Permission was given.

#### FLAGS AT BARILLO PARK

Trustee Libordi asked that the flag at Barillo be changed. He had a veteran mention that it was torn. DPW put up a new one.

#### SHED SETBACK

Resident James Bebout asked for clarification on the shed resolution as to whether all sheds in non compliance will be grandfathered in. Mayor Falci stated that he will wait for the Planning Board input. But most likely that will happen. Mr. Bebout stated that based on the zoning law the sheds should be 6' off the property line.

#### PUMPER PRESENTATION

Chief Mike Robbins gave a presentation to the board on the purchase of a pumper. They would like board approval to purchase a 2004 Spartan Crimson Pumper. It has a 1250 gallon pump, 1000 gallons of water, 30 gallons of foam and 7,000 miles and 500 hours on the motor. There is \$150,000 of equipment on the truck which was purchased on a FEMA grant - which has been released by FEMA. This truck new today would cost \$425,000. The chief would like the board to approve the expenditure of \$120,000 from capital reserve and borrow \$55,000 from Univest Capital, making two payments - one in June 2015 in amount of \$28,970 and the second in June 2016 at \$28,970. Money from the sale of the T15 will go back into the Fire department in repayment on the \$5,000 deposit.

A motion was made by Mayor Falci for the Fire department to precede drawing up legal paperwork for the 2004 Spartan Crimson Pumper, at which time the Mayor will review paperwork with village attorney followed by a meeting with the board to approve. Motion was seconded by Trustee Thomas and carried.
