BUDGET WORKSHOP

Mayor Falci gave a brief explanation regarding the upcoming budget workshops. He would like all Village departments to have their budgets to the board no later than February 1st.

MARICK PARK UPDATE - JOE INGALLS CHAIR

The planning board has been working on completing the new Marick Park subdivision plans. There are several parcels that are being requested to build on. The engineer (LaBella) working with owners Mr. and Mrs. Giles, noted that the DOH and DEC would respond to the plans by end of January or February.

Mr. Ingalls noted that the PB would like the right of way which will be turned over to the village after construction, be inspected and approved to Village specifications. This inspection could be done by the contractor or our DPW Supervisor.

Mayor asked if there is a limit on how many parcels can be sold this year. Mr. Ingalls stated that until plans are signed with approval from the DEC and DOT and the Giles have the Performance Bond in place parcels will not be sold.

There was a question as to how many parcels could be sold by law in the subdivisions. Trustee Thomas stated that they were told years ago that since more than three parcels were sold in one year, it qualified as a subdivision. Also subdivisions require street lights and sidewalks be put in. Mr. Ingalls stated that the Planning board thought it would be difficult to insist on sidewalks at this time since there are none in the already established areas of the Park. The intersection of East Lane and Marick Park will have a street light. The light on Mary Street that is not in service will be moved to the East Lane location.

OLD BUSINESS

TOWN FIRE CONTRACT

Mayor Falci explained the increases in the new contract the Village will get a 20% increase in five years with the new contract which will start next year.

Trustee Libordi questioned that the South Hornell contract which is only for two years will be commensurate with ours in the fifth. He found it irregular since we have a larger area. Fire chief Robbins stated that the money South Hornell get from the town pays for all the fuel for trucks upkeep on the building and bills on the building. That is the only money they receive to operate on. Town owns building and the firemen own the equipment. Trustee Libordi stated that if we do not get enough in the first or second year then that would mean additional tax money coming from the village residents. Trustee Thomas stated that there is a clause in the contract that it can be reopened at any time

A motion was made by Mayor Falci to accept the fire contract with the Town, seconded by Trustee DiRaimondo and carried.
