## SHERIFF'S REPORT

Mayor Falci reviewed the report received from the Steuben County Sheriff's department for patrol hours in February 2020.

Mileage for the month of February: 323 Miles at 57.5/mile

The board discussed the current coverage with the Steuben County's Sheriff's Department and the 5 year plan submitted by the Sheriff's department. The board discussed the possibility of having a public meeting to review the information in the submitted plan and answer any questions, comments or concern that the public may have.

Mayor John Falci has concerns that possible situations with the hospital are not being considered and need to be taken seriously. Mayor Falci said he just wants to be proactive and stay ahead of any situations.

Some questions and concerns that Mayor Falci said he had at this time are:

How many deputies are on call during weekends?

How many hours do we really need? Is 40 hours enough?

What is the response time to North Hornell for emergency purposes?

Trustee Frank Libordi suggested sending a letter to the town informing them that the Village of North Hornell is to be absolved of any liability should issues arise from the hospital. Also, a letter from Attorney Eric Shults to inform the town that they need to be held accountable

Mayor Falci and the board continued to discuss the proposed length of the agreement with the Sheriff's Department and if the board wants to move forward with the 5 year contract or something different.

Chief Robbins submitted his inventory list to the Board of Trustees and Mayor.

#### MAINTENANCE REPORT

Superintendent Rich Scavo reported on the chart of the flow of sewer going through the village provided to the board. Some discussion took place on this chart.

Superintendent Scavo asked for approval to purchase a new coded lock for the State Trooper entrance door. All members of the board agreed to move forward with the purchase of the lock at the proposed price of around \$270.00.

Superintendent Scavo informed the board of a Student Work Program being offered by Wildwood BOCES in Hornell. He proposed it would be good to give the student's participating in the program to work along with his staff. He feels it would give the students good "hands on" experience. The board had a discussion in reference to the request with Trustee Frank Libordi asking if the Village Attorney should look at the agreement. Mayor Falci will take the "Work Experience Agreement" to Attorney Eric Shults to get his opinion and re-visit this program in the future.

Superintendent Scavo reported village resident at 421 Cleveland Ave contacted the DPW in reference to having low pressure in their water. The resident asked to have it revisited in the spring. Superintendent agreed it should be revisited if the problem with pressure continues.

Superintendent Scavo reported the need to change the "No Parking" law to start December 1<sup>st</sup> and go through March 31<sup>st</sup>. Village Law states March 1<sup>st</sup>. Signs throughout the village are thought to state April 1<sup>st</sup> but village code needs to be changed to be consistent with the signs. Trustee Libordi said he can't believe that signs would have been

erected without the board making the change in the code. He suggested looking in to past meetings when the dates would have been changed. Trustee Ingalls said the code needs to be looked at and changed to be consistent with the signs posted in the village. Superintendent Scavo will look at all posted signs so this issue can be cleared up. It was discussed and agreed that the date should be re-visited due to past years accumulating snow continues well in to the month of April. Superintendent Scavo said he would look at signs currently posted in the village and report at a later date.

Superintendent Scavo provided photos of the 3<sup>rd</sup> Street Properties that he proposed at the previous meeting that the village consider purchasing for DPW use. He explained the intent of use along with the need for the proposed purchase for the said properties. He explained the situation with the City of Hornell and that the North Hornell DPW is no longer able to dump at the site in the City of Hornell unless it is just grass and brush. The above mentioned site would help eliminate the need to use the site in the City of Hornell for anything.

A motion to purchase the 3<sup>rd</sup> Street properties, tax map # 136.18-03-021-000 and 136.18-03-032.000 in the amount of \$5,000.00 for both parcels owned currently by Afton McCormick was made by Mayor John J. Falci, seconded by Joshua Greenthal and carried.
