Chief Michael Robbins gave the Fire Report.

Chief Robbins stated that Brush Truck 4 ('05) needs replacement. Issues found when truck taken in for oil change. The truck was purchased in 2008 at \$15,000. Breakdown of cost to repair the truck came to a total of \$23,203. Repair cost came from Simmons & Rockwell. Since the purchase of truck, Village has spent \$16,383 in repairs and paint. The Fire Chief would like to purchase a new truck. Funding for the truck would come from unexpended appropriations form the Village fire accounts, a \$10,000 trade in and the remainder of the balance would come from the Fire Company's account. Mileage put on truck was not available. The Chief would be purchasing on state bid price of \$36,800 from Maple City Dodge. All the equipment on old truck would be used for new truck. Trustees McCollumn and Trustee Ingalls would like to know miles per year put on truck and how the miles were used. Truck has 80,000 miles.

Mayor Falci asked if the truck is usable now and stated that we need to get another bid on motor replacement. Chief said truck will not be used unless necessary.

The Fire Company sold existing wall mounted racks at station for \$1,000 and purchased new for \$1,800. Chief Robbins would like the board to approve giving the \$1,000 from the sale of the racks back to the Fire Company. Trustee Ingalls questioned giving the money back since the Fire Company did not get approval from the Village Board to purchase the racks. Chief Robbins stated that they did not need approval.

Trustees agreed that this money should come directly to the Village. The board will not give the \$1,000 to the Fire Department at this time. Possibly use for the new truck purchase.

Approval was given for the placement of a legal ad to sell the Brush Truck for no less than \$10,000.

Trustee Libordi asked why body armor was purchased and where did money come from to purchase it. Chief Robbins stated that due to things happening in the area, it was purchased to make the firefighters safer. Trustee Libordi stated that other area departments do not have it. Chief Robbins state that the money for purchase came from fund raising.

Next month's agenda will include the Village's share for the Radio Grant - \$6883.

MAINTENANCE REPORT

Mayor Falci gave the Maintenance Report.

Trustee Libordi questioned a bill for the pump station generator repair. Is the Village paying for large amounts of waste and that is not generating any income. Trustee McCollumn questioned if we have been in touch with the City regarding expenses incurred. She would also like to know who is tied into the system that flows thru the Village pump station. Mayor Falci will have the information ready by May meeting to address who is tied into the sewer system north of the Village. He explained that there have been problems with the meter readings at both ends of the Village. The City owns the meter coming in on Rural Ave and the village owns the meter at the south end of Seneca Rd. Superintendent Scavo has been in touch with Mr. Dunning from the City regarding this problem.

Trustee Libordi noted that residents would like to have sidewalks repaired as one was done over the summer by our DPW. Mayor stated that it could be done over the summer months.

Trustee Ingalls asked if we have heard anything on the repairs on buildings with Bill Shull Plumbing. Mayor noted that the smaller things are being done and any larger repairs would come to the board. Trustee Ingalls also inquired about LED lights for Seneca Rd and if Superintendent Scavo heard anything on them.

Trustee Ingalls questioned if it is the Residents responsibility for maintenance and repair. If we are going to do this, we should be doing it for everyone in the Village.

DAVID PRETE FROM ELDERWOOD AT HORNELL

Mr. Prete gave an update on the construction going on at Elderwood. Over the past few months Elderwood has experienced leakage from the roof over the rehab unit which affects more than 24 beds. The work is now finished on the roof and renovation on the 24 rooms is going on. The unit is scheduled to reopen May 1. Elderwood is a sponsor of the Applebee's fundraiser for firefighters. A percentage of donations go to the fire company. June 15 will be a community health expo at the YMCA. Health care providers from all over the county will be on site.
