## **NEW BUSINESS**

### **BARILLO PARK**

Rich Scavo gave an update on the Joseph W Barillo Memorial Park event. The event is to be held on July 14<sup>th</sup> during the hours of 12PM to 4PM. Mr. Scavo would like the board to authorize the closing of Bowen St and Cleveland Ave from Bowne to Woodbury. There will be music in the Park supplied by Jim Dagon. Mr. Scavo requested that the Village supply the meat, rolls and condiments. He also requested that a new flag pole be ordered with a new flag and the shrubs around the memorial rock be taken down and replaced with something not so large. The large tree on the East side of the monument needs to be taken down for the flag to be seen. Small American and marine flags were ordered as well as two brass grave markers – one a Vietnam veteran marker and Marine Corp marker to be placed in front of the monument. The next meeting will be on Thursday at 10AM. Joseph Barillo’s family has been contacted about the event and is very supportive.

Trustee Libordi asked where the money came from to purchase the brass holders and flags. Clerk Libordi stated it was out of the Parks account from last year’s budget.

Mr. Scavo would like to investigate how we could rededicate the park so it is in the County list of parks He will also be in contact with local Veterans groups - AM Vets, American Legion & VFW.

The Fire department will help with tables, chairs and a generator.

The board authorized Mr. Scavo to send out letters to the local Veterans groups. A letter will also go out to Village residents notifying them of the event.

Mayor Falci made a motion to approve \$3000 to be used toward the flag pole and flags, shrubs, take down the tree and food for the Barillo Park dedication event on July 14<sup>th</sup>. The motion was seconded by Trustee Libordi and carried.

TANKER

Fire Chief Robbins presented a pamphlet of specs for a new 2012 tanker. He would like the board to review and consider this future purchase. Assistant chief Jeremy Smith reviewed the information and will be available for any questions the board may have. Mayor Falci would like to give this to a grant writer. Trustee Thomas asked what the fire department would be giving up if a tanker is purchased. Chief Robbins stated the Rescue truck and possibly the Ladder Truck.

Trustee Libordi noted that this was the first he knew of the tanker being presented. He would like the Fire department to set up a time to meet with the Trustees before it being addressed at a meeting. This gives the board more time to prepare.

Assistant Chief Smith stated that when the Department was doing the preplan for the tanker, it was noted that there are some hydrants in the Town that not working including ones by the BOCES campus. In the

Village their could be a problem with getting water to upper Third St and also the Heather Heights residents. Supervisor Zdanowski noted there is not enough pressure in hydrants at the North Hornell School. Chief Robbins stated that the capacity of combined water in our trucks is 2300 gallons. The board agreed that the hydrant issue needs to be addressed with the Town when the fire contract is negotiated.

Trustee Libordi asked if the Fire Chief could produce a map of the district we cover including the Village where there are issues with water pressure or hydrants and where the hydrants are located. The Chief said he will.

#### FLOORING BIDS – CONFERENCE ROOM

The Clerk informed the board that only one company has sent in a bid for the floor. The board would like the other companies contacted and the bids will be opened at next months meeting.

#### FIRE UNIFORMS CLEANED

Trustee Dick would like to see the Village pay Mr. Conley owner of Loohn's Cleaners to have the fireman's uniforms cleaned. Presently Mr. Conley is not charging for this service.
