#### **OLD BUSINESS**

## ST. JAMES UPDATE

Mayor Falci introduced St. James CFO Stan Konopko and Architect Mohamed Razak.

Mr. Konopko stated that the hospital was awarded a \$54mil grant after completion of a rigorous application of why a new facility was needed. The hospital now has to complete a Certificate of Need to the Department of Health in order to receive the grant money. This will outline the programs and services that will be offered at the new facility. This is all being done with the assistance of the University of Rochester Medical Center in order to meet the deadline to obtain the funding. To receive the funding there must be an execution of a contract with the upstate provider grant program and then along with the contract they need to file a CON to show all construction of new facility. This is all submitted to the Dept of Health. St. James deadline for submittal is August 31<sup>st</sup>.

Mr. Razak gave an update on the site development. The Site plan should be ready for presentation with a month.

#### BRIDGE UPDATE

Mayor Falci stated that the steel is to be on site by June 20<sup>th</sup> in addition to a crane. They are still planning on a completion date of October.

## SENECA RD UPDATE

The mill and fill of Seneca Rd will be sometime in July. There have been requests from residents for the milling. Supervisor Scavo will be let them know when it is available. The School crossing on the corner of Seneca Rd and Woodbury will have cut out curbs for handicap accessibility.
