#### FIRE DEPARTMENT SHED

The Mayor would like the Fire department to find a place for the new shed to be placed. Rich Scavo received a price from Lowes on a 12 x 24 shed. Shed to be placed on a concrete pad.

#### ARKPORT RESIDENT

Chris Doran from Arkport asked if the Village board endorses the actions of Trustee Libordi regarding the Town of Hornellsville.

Mayor Falci stated the same thing that he told Mr. Isaman two years ago: Mr. Libordi has the right to question and challenge the governing body of the Town of Hornellsville. Mr. Libordi does not represent the Village of North Hornell and when he goes to a Hornellsville meeting he goes as a private citizen.

## **GENERATOR**

Chief Robbins recommended that the Board go with the air cooled generator price from Chapman's Electric. Cost would be \$12,500 – Generator \$7,000 & Install \$4,500. Mayor asked the Chief to check County prices.

# COUNTY MAP SHOWING FLAITZ PROPERTY AND VILLAGE PROPERTY

The board looked at parcels owned by the Village and those owned by the Flaitz family. The proposal is that the Village will give its parcels to the Flaitz's in exchange for parcels that the Village would take for water and sewer extensions and land for Village business. The Village will also have a permanent easement with the Flaitz for an area of the Third St road. for the Flaitz's to enter their property.
