Chief Robbins spoke of the \$215,000 from Senator O'Mara to be used towards the purchase of a new pumper tanker (\$200,000) and Water Rescue Equipment (\$15,000) for the dam and other waterways in the district. It will take 9 – 12 months for paperwork to be processed. If the Board is in agreement, the Chief would like to put the tanker out for bid. This Wednesday Senator O'Mara will be at the Fire Station to award the money. The Chief explained that the money received as a result of the drowning at the dam and the building of the new hospital. Also noted, the Elderwood nursing facility's emergency plan is to use the North Hornell tanker if their water system shuts down. The department will sell Engine 58 and proceeds will go towards the new tanker.

Trustee McCollumn would like something in writing showing the money coming.

Mayor Falci thanked Mike Palmesano for all his work with Senator Thomas O'Mara in acquiring State funding for the equipment.
