UPDATES FROM THE MAYOR

The bridge on Seneca Rd. is moving along well. November 1 is the opening date, but hopefully it will be sooner. The week of the 15 they should be doing the road approaches to the bridge. Hopefully it will coincide with the milling.

Mayor Falci has been in contact with Hospital architect Mohamed Razak regarding the progress of the site. Mr. Razak informed him that they are working on the Certificate of Need and the final requirements and documents that have to go to the state such starting and finishing times. They are trying to tie up any loose ends regarding St. James partnership with the U of R. This should be completed by August 31st. Mayor will be given more information this week from the architect.

The Village should receive site information sometime in September. Trustee Ingalls asked if they are realistically going to break ground in October. The Mayor didn't know. Mr. Razak did tell the Mayor that everything is on schedule the way they have planned. He will ask Mr. Razak tomorrow. The Mayor also has questions regarding the ZBA.

Trustee Libordi asked if it sounded reasonable that they would break ground in October and we have not received any information as of yet. Trustee Ingalls also questioned this. They should have a GANTT schedule. Trustee Libordi mentioned that IDA Rep Sam Nasca was on the radio stating when asked about St. James news, he stated that there was nothing he was at liberty to release at this time. Possibly the IDA should be contacted. The Mayor will ask Mr. Razak to speak at our September meeting.

Pictures will be taken of Trustees and Mayor at next months meeting for the web site. Trying to get website updated. September 12th board meeting is the deadline for all departments and board members to have all information they want in the newsletter for October. This should go to the Clerk.

OTHER

Resident Don Hockenberry asked if there was going to be discussion on Chambers St. Mayor Falci stated that the sale went through and Ms McCollumn does not plan to build until March of next year. Mr. Hockenberry asked if she owned the lot and could someone else possibly buy it. The Mayor stated that she doesn't own it yet and that it is already approved to sell to her. Mr. Hockenberry also asked about the alley that is torn up from her sewer install. Will she fix it? The board said it should be repaired. The Mayor will look into who is responsible for the repair. He will look into homes put in on Rural Ave and Third St. Did the residents repair or did the DPW repair. Resident Mark VanDurme stated that the 10 MPH sign is not visible from the Pittsburg entrance. It should be turned so people can see it.

Mr. Hockenberry also noted that the Village parcel on Chambers St. is not being maintained.

Trustee DiRaimondo asked what is going on with the Dieter property. Mayor stated that Mr. Dieter has made some improvements but needs to do more. He will have CEO Rusby take pictures of the area and determine if another letter needs to go out. If Mr. Dieter doesn't respond, he will be sent an appearance ticket.
