Mayor Falci explained that the purpose of the hearing was to gather public input on proposed local laws 1, and 2. Local Law # 1 proposes control and licensing of cats, Local Law # 2 is an addition to the dog law.

Jack Graham questioned on page section 36-2 definitions it states that the owner of the ct need not be resident of the Village to be issued a summons and I see no such definition in the proposed dog law.

Mayor Falci: This is an amendment to the existing dog law and it states in our law that any owner can be issued a summons.

Joel Poplawski: I am unhappy with the cat law, it does not that the person annoyed by the cat has to address the cat owner in any way, so that I would have an opportunity to deal with it before it becomes a legal matter. The content of a nuisance, anyone who hates cats just seeing one would be a nuisance for them so that means I can be penalized for someone just seeing my cat.

Joyce Norfolk: Cats are affectionate and beneficial to humans. We have taken in cats and had them fixed and it is the human beings that cause the problem because they won't take care of them and drop them off.

Joe Dick: Owners of cats have never had to comply with the law as owners of dogs do, put it on the books and enforce it.
