NEW BUSINESS

NYSEG LIGHTS

Superintendent Scavo has no new information on the LED lights for the Village streets. Time frame would be within a year. They change out the heads and the Village pays the remaining rent

\$2,700. The cost for the electric on the new heads will be much less than current rate. Village should see a \$6,000 cut in electric costs per year.

STATE TRANSPORTATION SIGNS

Trustee Libordi gave the update. A diagram of the types of vehicles affected by the no commercial traffic signs was given out along with the location of signs. He would recommend restricting 10 - 18 wheelers. That would be 10,000 #'s ton 26,000 #'s. Trucks that are doing business for Village residents are not included.

A proposal is needed from Eric Shults and sent to Albany. Then signs can be located with the assistance of OIC Richardson as shown on the diagram. The Mayor will contact Eric Shults. Trustee Libordi will contact the DOT in Albany to get contact information for Mr. Shults if needed.

PROPOSED EMPLOYEE BENEFIT PACKAGE

REPLACEMENT TREE PROGRAM

Mayor noted that trees were taken down on Seneca Rd in preparation for the sidewalk and curb project. Many residents were not in favor of this. Mayor has a project were trees will be replaced in front of residents lots were trees were removed. Trustee Ingalls is looking into acquiring trees and offering them at a reduced price to other Village residents. If more trees are purchased, hopefully the Village will get a better price. Plantings would be in fall or spring.

SENECA RD. LAND SALE

Mayor talked about the Avondale property and possible development. Is the board interested in selling the land for single family one floor housing? The same idea is being talked about the Seneca Rd Property. The board would like to see the Seneca Property possibly sold for three parcels. There was more discussion on both parcels as to what should be done and what type of housing to be considered. Also, where are water and sewer lines coming into the Seneca Rd. property? All agreed that multiple appraisals should be done on both.

OLD BUSINESS

TAP UPDATE

Trustee Ingalls stated that Lu Engineers has gone thru the review process and recommended to award the bid to the Dolomite Products Company (AL Blades) the low bidder at \$1,718,882.08. A resident questioned the additional amount and how it was to be paid for. Trustee Ingalls stated that the initial total project cost was estimated to be \$1,379,000 and the bid for construction was \$1,718,882.08. If the board proceeds with the project the additional amount will be bonded. Mayor Falci noted that the fire hall bond will be paid off this year and if the Seneca Rd land is sold, the Village will have no debt. If the Village has to bond for an additional 10 years it should not have an additional affect on the budget.

FURNACE REPAIR / REPLACEMENT

Superintendent Scavo gave the board three quotes for the replacement of the furnace. The current boiler cannot be repaired.

Mike Palmer \$13,472

Phoenix Heat \$15,600

Kuhn's Plumb \$13,266

Prices do not include prevailing wage.

In the current budget, \$8,000 was to be appropriated for a new boiler. Additional amounts will be out of Buildings Capital Reserve.

Superintendent Scavo will have corrected prices for the Wednesday budget meeting.
